#### DEFINITION

In this Release Agreement, the term "AZAMI SPORTS Activities" shall include all water, team building and adventure camp activities, all services and events provided, arranged, organised, sponsored or authorized by the Releasees and shall include but is not limited to: use of facilities ; use of equipment; demonstrations; instruction and orientational courses; and any other activities, events and services connected in any way with or related to Azami Sports.

#### ASSUMPTION OF RISKS

I am aware that participating in the AZAMI SPORTS Activites involves risk of injury and hazards and other dangers, including but not limited to: collisions with other participants and clients or objects; malfunction of vehicles and equipment including breakage of cables, ropes, harness and apparatus; slips, falls, sprains, strains, stress, shock or other injury to the body while participating; negligence of other persons; and NEGLIGENCE ON THE PART OF THE RELEASEES. I UNDERSTAND THAT NEGLIGENCE INCLUDES FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO PROTECT OR SAFEGUARD ME FROM THE RISKS, HAZARDS AND DANGERS OF PARTICIPATING.

I AM AWARE OF THE RISKS, HAZARDS AND DANGERS OF PARTICIPACTION AND FREELY ACCEPT AND FULLY ASSUME ALL SUCH RISKS, HAZARDS AND DANGERS AND THE POSSIBILITY OF INJURY, DEATH, PROPERTY DAMAGE OR LOSS RESULTING THEREFROM.

#### MEDICAL CONDITION

I am aware that participating in any or all of the above activities can place unusual stresses on the body. I acknowledge that this is notification that I should consult with a medical professional if I have any concerns about my medical condition or physical ability to participate.

#### RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

I HEREBY AGREE:

- 1 To waive any and all claims that I have or may in the future have against the Releasees and **TO RELEASE THE RELEASEES** from any and all liability for any loss, expense, damage, or injury including dismemberment and/or death that I may suffer, or that my next of kin may suffer as a result of my participation in any AZAMI SPORTS Activities;
- 2 To hold harmless and indemnify the Releasees for any and all liability for any property damage or personal injury to any third party resulting from my participation in any AZAMI SPORTS Activities;
- 3 This Release Agreement shall be effective and binding upon my heirs, next of kin, executors administrators, assigns and representatives, in the event of my incapacity or death;
- 4 This Release Agreement and any rights, duties and obligations between the parties in this Release Agreement shall be governed and interpreted solely by the laws of the Province of British Columbia and no other jurisdiction; and
- 5 Any litigation involving the parties in this Release Agreement shall be conducted solely within the Province of British Columbia and shall be within the exclusive jurisdiction of the Courts of the Province of British Columbia.

In agreeing to enter into this Release Agreement I am not relying on any other oral or written representations or statements made by the Releasees regarding the safety of participation.

I HEREBY CONFRIM THAT I HAVE READ AND UNDERSTOOD THIS RELEASE AGREEMENT PRIOR TO SIGNING IT, AND I AM AWARE THAT BY SIGNING THIS RELEASE AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ASSIGNS, ADMINISTRATORS, AND REPRESENTATIVES MAY HAVE AGAINST THE RELEASEES.
